President's Comments

Mrs. Kiefer:

- Thanked Mrs. Heddleston, Mrs. Baughman, Mrs. Besh, the High School French Club and all the staff for an enjoyable evening at the Title I Family Night at Park Elementary School.
- Mrs. Kiefer introduced newly appointed Board member Mary Yuhas. She congratulated the middle school team of students who took 3rd place in the gifted competition.

Student Representative to the Board

Mr. Brandon Tomasic:

- Reported that the kindergarten students celebrated the 100th day of school on February 10 by counting to 100, making necklaces out of 100 fruit loops and other counting activities.
- The Queen of Hearts visited Franklin Primary Center on February 19. The kindergarten students will participate in reading activities during Read Across America Week February 24-28. At the middle school, students and teachers have been engaged in lessons and activities focused on influential African-Americans.
- The middle school boys basketball team ended their season winning four of their last six games. The teachers are working hard to ensure students are ready for the PSSA assessment.
- At the high school, Brandon reported that the boys basketball team qualified for the WPIAL playoffs and played a hard fought game against Mars but lost in overtime.
- The Harmony Club of Homestead presented an assembly to the juniors and seniors on the relevance of African music today.
- The High School hosted the Pennsylvania Literacy Network Conference, and teachers from North Allegheny, Hampton, Woodland Hills, Northgate and McKeesport school districts attended.
- The Drama Club will present *Annie* on March 6, 7 & 8 at 7:30 PM and on March 9 at 2:00 PM. Tickets are \$8 for adults and \$1 for students in kindergarten through 5th grade. On March 5th, the cast performed for students in kindergarten, 4th and 5th grades.

Superintendent's Report

Mr. Wehrer:

- Invited the parents of young learners to an Early Kindergarten Registration to be held on Tuesday, March 11. This registration will occur at the Franklin Primary Center beginning at 2:30 p.m. until 5:00 p.m. to allow working parents to register their children early. Parents may enroll their children who will be 5 years of age on or before September 1st of this year for the 2014-2015 school year.
- During February, the students in the Steel Valley School District have been exploring the achievements and influences of African-Americans in our country.
- On Tuesday, Steel Valley High School juniors and seniors were treated to an engaging presentation by the Harmony Club of Homestead on the history of African-American music and a demonstration of how classic secular music is still relevant to them today.
- During the event, students learned how some of their favorite artists pay homage to classic African-American artists such as Shirley Bassey, Nina Simone, Ella Fitzgerald, Billie Holiday, Betty Wright, James Brown, Nat King Cole, Ray Charles and more. They also learned about the basic evolution of African-American music from the fields of slavery to modern day during the interactive presentation and were treated to a performance of a few pieces demonstrating the evolution of African-American music.
- Elementary Principal Kevin Walsh reported that during an assembly at Barrett School, Greg Kenney portrayed Jackie Robinson, and the students were engaged in the program. Fifth Grade Student Evan Coleman along with his 5th grade teachers Ms. Katie Pisula and Ms. Jonette Bost reported on the posters, research papers and videos created by students.
- Fifth grade students from Barrett Elementary School created a video of *Name That Tune* in which they performed a variety of songs for others to guess the song titles made famous by African-American artists.
- Mrs. Lauren Baughman, Principal of Franklin Primary Center and Park Elementary School, shared biography books created by the kindergarten classes using Kid Writing about Barack Obama, Jesse Owens, Roberto Clemente, Rosa Parks, Ruby Bridges and Louie Armstrong.
- To honor famous African-Americans, the third grade students at Park Elementary School created reports in which they spoke from that person's point of view. They even chose to dress up as Roberto Clemente, Rosa Parks, Maya Angelou, Martin Luther King, Jr., Tiger Woods, Cullen Andrew Jones and Michael Jordan. The students who portrayed these famous people were Jason Poniewaz, Brenna Kern, Dacia Hruska, Connor

- Brady, Julie Spader, Amelia Carr and Brooke Farrah.
- Mrs. Toni Besh, High School French teacher, discussed how she combined French culture and African folk tales in her French classes. Students also selected someone in a French speaking country and created a fake Facebook page of them.
 - In the middle school, the eighth grade science students wrote essays on African-American inventors and how they impacted the students' lives.
 - Mr. Wehrer introduced Kevin Rice, Director of Steel Center Area Vocational-Technical School, and congratulated him for the distinction of being named Career Technology Education Director of the Year for the Western Region of Pennsylvania. Mr. Kevin Rice discussed the importance of career technology education, and that it is in a state of change with significant modifications on how we teach students. There are currently 15 programs for students to consider at Steel Center.
 - On January 30, six students were honored at a reception at Steel Center Vocational-Technical School for winning the second quarter *Extra Effort Award*. Students included Tara Dudas, cosmetology; Tom Pepke, food service; Amber Birkhamer, health assistant; Anthony Brookins, heating, ventilation & air conditioning; Brittany Connors, protective services; and Heather Demeda, retail food merchandising & production. *Extra Effort Award* recipients are chosen by shop instructors each quarter for their demonstration of outstanding attitude, work ethics, attendance and dependability.
 - Mr. Wehrer recognized Steel Valley High School and Steel Center Vocational-Technical School students who were selected as *Top of the Shop* awardees for the first semester of 2013-14.
 - Joseph Radakovich, Grade 11 Automotive Mechanics; Ryan Ackerman, Grade 11 Building Trades Maintenance; Kyle Suhajda Grade 12, Carpentry; Caleb Groce, Grade 10 Culinary Arts; and Melissa Kniss, Grade 10 Health Assistant. The awards are given once each semester during an all-school ceremony to students who exemplify outstanding achievement.
