Mrs. Kubancsek moved and Mrs. Sloan seconded the motion to approve the purchase of memorial books to be placed into the district

libraries in memory of the above departed. Upon roll call the following members voted affirmatively: Ducar, Fedor, Heddleston, Ed McCallister, Tim McCallister, Sloan, Terrick, Kubancsek and Cannon. Negative: None. Motion carried.

Citizen Comments on Agenda Items

Mr. Vince Natale questioned items from the March 20, 2007, worksession agenda, specifically Item 2.3 (asbestos inspection of the Woodlawn building), Item 2.4, (proposal for the repairs to roofs at buildings) and Item 2.5 (proposal to advertise for bids for roof replacement) were removed from the March 27, 2007 agenda. It was advised by Solicitor Donald Fetzko and that the asbestos inspection had been done previously and the cost to raze the Woodlawn building would be \$800,000.

Regarding Item 2.4 (proposal for the repairs to roofs at buildings) Mr. Fetzko stated that the bid on the Park School roof was done only ten years ago. Mr. Keesecker said it was a good roof, put over a bad roof. Mr. Fetzko stated we may have a warranty and would speak to John Yaklich.

Regarding Item 2.5 (proposal to advertise for bids for roof replacement at Park Elementary), Mr. Fetzko stated that this item should be bid since it is over \$10,000. Mr. Ducar stated that the district is part of a consortium and state negotiated bid list so it doesn't need to be bid. Mr. Fetzko confirmed that if we use the price from the state bid list, the item doesn't need bid. Mrs. Fedor asked Mr. Fetzko if his opinion is to table, and his reply was yes, to look into it further. Mr. Ducar said we have \$3.3 million to spend in three years for capital improvements.

Superintendent's Report

Mr. Ed McCallister asked to move the comments and recognize the students in attendance.

Dr. Kinavey recognized Toni Besh, French teacher, for being named an Honoree for the Teacher Excellence Program. Mrs. Besh will be recognized at the Celebration of Teaching Event on April 19 at which time she will learn if she receives one of the \$2,500 grants.

Fourth and fifth grade students showcased the *Freedom Train* program under the direction of teachers Karen Catterall, Lori Kenavey, Sharon Kampe, Student Teacher Robert Saunders and Media Specialist LuAnne Szczypinski. The students learned behind the scenes procedures, worked on public speaking skills, researched and studied the characters they portray through the Readers' Theatre project. The 4th grade students who participated were Jayla Irving, Alyssa Mackey, Shailyn DelGado, Miles Smith, Amonte Gwinn, Amanda Merling, and the 5th grade students included Naydina Phillips, Sashah Groce, Joseph Yano, Rykai Wright, Jeffrey Garnder, Deon Worthy and Shauna Ingraham.

Returning to Citizen Comments on Agenda Items

Mrs. Paula Borsch asked general questions regarding the agenda and who sets it. The Superintendent's Office prepares the agenda and Dr. Kinavey approves items to be presented for or removed from the agenda.

Mrs. Borsch noted that on under "Personnel" section, Item 6.1 (unpaid leave of absence) and Item 6.2 (family medical leave of absence) but nothing about Mr. Bichko.

Mr. Fetzko stated it is a personnel matter and the district cannot comment. Mrs. Borsch questioned who has the authority to suspend an employee if on a paid leave. Mr. Fetzko said the Board must approve the leave eventually.

Mr. Fetzko said the procedure is written in the public School Code under the title "Business Manager".

Mrs. Borsch said she has the guidelines and wants to make sure a vote was not taken in executive session.

Ms. Donna Dreshman noted that the word "new" should be placed next to Item 1.6 (the advertising of supply bids for the 2007-2008 school year). In reference to Items 2.3, 2.4, 2.5, were these items pulled from the agenda during executive session. She requested copies of Items 1.1.11(Steel Valley Foundation for Education Statement of Income and Expenses for the month ending February 28, 2007), 2.1 (facility rental requests), 2.2 (fundraising requests), 5.2 (revisions to 2006-2007 school calendar) and 5.3 (proposed

2007-2008 school calendar), and commended the Board for Policy No. 4.1 (second reading of revision to Policy No. 801 Public Records.)

Mr. Natale stated that if an item is deleted from the agenda of a worksession meeting and when the subsequent agenda for the regular meeting is prepared, it has the appearance of looking dishonest if removing the item from the worksession agenda is not so noted on the regular meeting's agenda.

Mr. Ducar noted that he was not notified as Chairperson of the Operations Committee that any item was pulled from the agenda.

President's Comments

- Commended the Drama Club and Mr. Altman and the staff on the phenomenal musical and that the district has an incredible amount of talent in our community.

Director of Secondary Education

Ms. Fenyus:

- Announced that 51 Middle School students raised \$1,957.46 from the Math-A-Thon to benefit St. Jude Children's Hospital, under the promotion of Mrs. Beth McCallister
- Sixth grader Logan Perry took part in the regional Spelling Bee at the University of Pittsburgh.
- On March 24, five middle school students participated in a National History Day competition at the Heinz History Center. The students performed an original skit based on the Homestead Steel Strike of 1892. Student participants included Kayla Baird as Andrew Carnegie, Alaina Bott as Henry Clay Frick, Taylor Wellman as Homestead Mayor John McLuckie, Sandra Alhaj as union leader Hugh O'Donnell and Sara Fallon

as the narrator. Teachers Mr. Ivan Braszo and Mr. Mark Fallon sponsored the group.

- Students who achieve a 3.0 or higher on their report card or progress report are eligible for a 50% discount on a one-month Athletic Club membership at the Carnegie Library of Homestead. Students with a 2.5-2.9 GPA will receive a 33% discount. Students who attend school 30 consecutive days without an unexcused absence or suspensions will receive a 25% discount. This program will begin with the 3rd quarter report card. Guidance counselors will provide students with a certificate to present to the library for the discounted membership. A regular club membership rate is \$30 per month.
- The district is now accepting donations for the Geri Palmieri Scholarship Fund. Please send any donations to Ms. Fenyus or Mrs. Geyer at the Senior High School.
- Munhall High School graduates from the Class of 1949 have offered to donate \$1,000 to the high school library for books to be placed in memory of Miss Margaret Howat, retired Head Librarian of the Munhall and Steel Valley School Districts.
- A Parents' Night Out is planned for April 12 from 6:30-8:30 p.m. in the high school cafeteria. The Student Learning Team, comprised of teachers, parents and administrators is planning an early childhood literacy event for parents and their children.
- The Community Leaders Breakfast will be held on April 18 beginning at 8:30 a.m. until 10:00 a.m. in the high school cafeteria. The high school Rhythm Club and students from the Music Technology program will perform. Dr. Kinavey will address the accomplishments of the school district. The proceeds from this event support the Mon Valley Great Idea Grant program.
- The Veterans' Day Committee and the Munhall Garden Club are planning a dedication of a Blue Star Bi-Way on April 14 at 11:30 a.m. at the Carnegie Library of Homestead.
- The Steel Valley Chamber of Commerce honored the Veterans' Day Committee, Mrs. Sharon Fisher, Chief Irvin Williams, Students Melissa Kaufold, Ian Mehok, Sara Fallon and Tyler Votedian at the annual Outstanding Citizens Dinner on March 29.
- Reported that the PSSA testing went well at the middle school and high school. She thanked the principals, teachers and

students for their hard work during testing week. As a reward, 11th graders enjoyed an ice cream social and the 8th graders went on a bowling trip. Various gift certificates, prizes and iPods were raffled off to students with perfect attendance and positive behavior during the testing. Ms. Fenyus thanked Mr. and Mrs. McCallister, Ms. Sabo and Mr. Colebank of their help with the activities and incentives.

- Distributed an overview of the national and local SAT scores. Out of the 80 students who took the SAT in 2006, 42 students scored higher than the national average on the writing section, 44 students scored higher than the average in reading, and 55 scored higher than the average in math. She reported that the district is partnering to create an SAT tutoring program for students in grades 8-11. In the meantime, students have the opportunity to take the Test-Taking Strategies course at the high school.
- National Testing Day is April 28, and in order to encourage students to practice taking the SAT or ACT the Princeton Review is offering free practice testing at St. Edmund's Academy in Squirrel Hill. Students are encouraged to take this practice test in order to help strengthen standardized test taking skills. Citizens Comments

Ms. Paula Borsch thanked the Board for the minutes being placed on the district's website and asked the status if capital funds are not spent within three years, will the IRS require the district to pay interest. Mr. Fetzko responded that if 80% is spent within three years, there is no fine.

Mrs. Borsch asked for a copy of the solicitor's duties and responsibilities of the job. Mr. Fetzko stated his job description is listed in the School Code and that he answers all legal questions.

Mrs. Borsch said more microphones are needed.

Mrs. Borsch asked for copies of teacher certificates. Mr. Heddleston noted social security numbers are on certificates. Dr. Kinavey will look into this matter.

Ms. Dreshman questioned Item 6.9 (services of John Yaklich) and Dr. Kinavey stated Mr. Yaklich will be working as needed for 3-5 days a week, with no term set. Ms. Dreshman noted that Mr. Yaklich was brought in before and we can't always bring someone in to bail us out.

Regarding the \$3.3 million for the 2005 Capital Projects Fund, can the money be used to fix the pool? Mr. Fetzko said the Board must decide what to improve. There is one year left to make the capital improvements. Mrs. Fedor asked for documentation on how we have spent the money thus far and the plans for additional improvements.

Ms. Dreshman asked for a rough figure of what Dr. Warren was paid. Mr. Ducar said \$75,000, \$25,000 a year for three years.

Adjournment

Mrs. Terrick moved and Mrs. Kubancsek seconded the motion to adjourn the meeting.
