President's Report

- Congratulated the girls volleyball, varsity football and boys soccer teams for their hard work and dedication and success in the post season.

- Reported on the activities at Park Elementary School. On October 15, the local firemen provided students with information on fire safety. The men and women also had an opportunity to eat lunch with the students.
- During the month of October, Park School's staff participated in a schoolwide Oleweus Bullying Prevention training. This nationally recognized program provided all staff members with skills needed to react to bullying situations and create a school environment that is safe for all.
- On October 27, Park School will be hosting a kick-off event for its bullying prevention program with "We're Not Afraid of Bullies" Halloween dance.
- At the middle school, Quarterback Charlie Batch and the Steelers Rookie club, visited students at the middle school to "Play 60". They also donated \$5,000 to the school for physical education equipment.
- The middle school English and PSSA teachers are working with Dr. Tracey Czajkowski on improving writing. They have met four times to learn about writing across the curriculum.
- The Alice Club, which is a computer program that allows students to create their own video games, has been meeting after school in the middle school. Mr. Singer is the club sponsor.

- Reported on a book discussion held at the Carnegie Library by 9th grade students on the book *A Lesson Before Dying* by Ernest Gaines. Students will be attending a mock trial at CCAC on Friday as part of the One College, One Community program.
- The 28th Annual Veterans Day ceremony will take place on November 11 at the high school. Secondary students are participating in an essay contest around the theme *Service and Sacrifice*. The juniors and senior participated in the Safety Bug program. The fall play auditions took place.

Superintendent's Report

Dr. Kinavey:

- Congratulated Park School Guidance Counselor Brandi Chalus who recently earned National Counselor Certification by meeting the professional counseling standards set by the National Board for Certified Counselors. She joins five other teachers and counselors with National Board Certification including Susan Large, middle school counselor; Susan Olsen, high school biology teacher; Yvette Logan, high school chemistry teacher; Maria Heddleston, elementary instructional resource teacher; and Roslyn Stulga, elementary art teacher.
- On Thursday afternoon, Senior Delrece Williams will be recognized as Student Athlete of the Week by WTAE-TV. Mrs. Cannon added that Delrece holds the new Steel Valley record for the most rushing yards in a single season. He will be attempting to break a WPIAL record on Friday night. We wish him the best.

Director of Pupil Personnel, Special Service & Elementary Education

Mrs. Borges:

- Mrs. Shelley Hiegel, Coordinator of School and Community Services for ACI, presented information about the Parent-Child Interaction Therapy (PCIT) program. This is a form of therapy for children ages 2 to 7 to promote effective behavior management and discipline techniques as well as enhance a positive relationship between parent and child. Live coaching helps parents learn what they are doing well and provides support with skills they need to master. A classroom will be created at Barrett Elementary School to institute the 12-20 week program.
- For the 4th year, Steel Valley has been awarded the Special Education School Wide Positive Behavior Grant in the amount of \$41,775. We were one of 62 school districts to receive these funds.

Director of Academics, Information & Technology

Mr. Colebank:

- Recognized Calculus Teacher Tim Vickers and Student Christina Martin. Mr. Vickers and Mrs. McCallister accompanied a group of advanced math students to the Arnold Ross Lecture for gifted math students held at the Carnegie Science Center. Ms. Christina Martin was invited to participate in *Who Wants to be a Mathematician* game show sponsored by the American Mathematical Society. She took 2nd place in the competition and won a T-Inspire graphing calculator and \$500.
