## **Selection of Temporary Chairperson**

Mr. Rojtas moved and Mrs. Steele seconded the motion to appoint Mr. Terrick as Temporary Chairperson. Upon roll call the following members voted affirmatively: Ballas, Bulger, Colasante, Rojtas, Steele, Terrick, Yuhas and Youngblood.

Mr. Terrick is motioned as the Temporary Chairperson.

#### Nominations/Election of President

Mrs. Ballas moved and Mr. Colasante seconded the motion to nominate Mr. Bulger as President of the Board of Directors. Upon roll call the following members voted affirmatively: Ballas, Bulger, Colasante, Rojtas.

Mrs. Steele moved and Mrs. Yuhas seconded the motion to nominate Ms. Youngblood as President of the Board of Directors. Upon roll call the following members voted affirmatively: Steele, Terrick, Youngblood and Yuhas.

The motion for President was tied between Ms. Youngblood and Mr. Bulger. Discussion ensued regarding the vote, at which time, Mr. Bulger graciously removed his name as a candidate for the President's position.

Mrs. Steele moved and Mrs. Yuhas seconded the motion to appoint Ms. Youngblood as President of the Board of Directors. Upon roll call the following members voted affirmatively: Bulger, Colasante, Rojtas, Steele, Terrick, Youngblood and Yuhas.

Negative: Ballas. Motion carried.

Ms. Youngblood is elected as President of the Board of Directors. She thanked her fellow board members for the vote of confidence and her election to office.

#### Nominations/Election of Vice President

Mr. Terrick moved and Mrs. Yuhas seconded the motion to nominate Mrs. Steele as Vice President of the Board of Directors. Upon roll call the following members voted affirmatively: Steele, Terrick, Youngblood and Yuhas.

Mrs. Ballas moved and Mr. Rojtas seconded the motion to nominate Mr. Bulger as Vice President of the Board of Directors. Upon roll call the following members voted affirmatively: Ballas, Bulger, Colasante and Rojtas.

The Vice President's Position was tied between the Mrs. Steele and Mr. Bulger. Madam President Youngblood requested of the two candidates a question why they two would like to be Vice President. Both candidates responded to their reasons for serving as a Vice President.

Subsequently Madam President requested a second round of votes for the Vice President's position. In the midst of the election process Mr. Bulger graciously withdrew his name from nomination.

In order to properly record the voting the process started anew. Mr. Terrick moved and Mr. Bulger seconded the motion to appoint Mrs. Steele as Vice President of the Board of Directors. Upon roll call the following members voted affirmatively: Bulger, Colasante, Rojtas, Steele, Terrick, Youngblood and Yuhas. Negative: Ballas. Motion carried.

Mrs. Steele is selected as Vice President. Mrs. Steele thanked the Board. Mr. Terrick further stated his pleasure regarding Mr. Bulger's ambition and motivation to become President and Vice-President. He ended his statement by stating that Mr. Bulger's time will come where he will hold an officer's position.
